### Compliance

As a supplier of RMC we will comply with all applicable laws and regulations and codes of conduct where applicable. As a supplier to RMC we will comply with local laws and relevant agreements regarding working hours. We will ensure that wages paid to employees and hired labor are considered fair and in compliance with local laws and agreements.

We follow internationally acceptable ethical standards and shall not offer or receive improper gifts or payment in connection with contract bidding, evaluation or award or to obtain or retain business. As a supplier to RMC we will follow international legislation on bribery and corruption.

### Employment Principles

As a supplier we shall follow national laws and will not employ children under the age of 15 or any other against their own free will, nor will our personnel be required to lodge "deposits" or identity papers upon commencing employment. We will treat our employees and hired labor equally and fairly. We will not accept any form of harassment or discrimination based on age, gender, religion or any other reason.

### Health, Safety and Environment (HSE)

As a supplier to RMC we will work, through continuous improvement, for a healthy, safe and secure work environment which as a minimum is always in accordance with applicable laws and local (work site) regulations and permits.

As a supplier to RMC we will work to minimize negative impacts on the environment by continuously developing practices compatible with sustainable development. As a supplier to RMC we will consider the full life cycle of our work, products and how we can minimize negative impacts on the environment. We will comply with national and local (worksite) environmental legislation and discharge permits. As a supplier or subcontractor to RMC we will strive to have the best possible management system for HSE.

### Requirement towards Supplier Network

As a supplier to RMC we will promote the implementation of the principles set forth in this Declaration towards own suppliers and subcontractors.

We, the supplier, confirm that we fulfil the requirements in this Declaration.

We agree that RMC may audit our practices in the aforementioned areas so as to make sure we comply with the requirements. We are aware that a deviation from above principles can be regarded as material breach and where such deviation cannot be corrected in the RMC's reasonable opinion the business relations may be terminated.
